

The following results have been recorded between 16.12.2018-16.01.2019. These are background results and do not include work activities as we only commenced demolition works on 29.01.2019. No exceedances have occurred within the monitoring period of either 250 µg/m3 15 – minute interval(Graphs 1-4) or a 50 µg/m3 24 hour interval (Graph 5). Background PM10 levels range from a minimum value of 0.0 µg/m3 to a maximum value of 31.34µg/m3. There is not a correlation between values of PM10 vs time. The relationship is scattered. As the PM10 values recorded are, for the most part, minor quantities have been recorded

Graph 1. Summary graph displaying PM10 results and threshold exceedances for monitor 807.





Graph 4. Summary graph displaying PM10 results and threshold exceedances for monitor 807.






